Cumberland’s Academic Standards limit a student to four credit hours in any term, and no more than a total of 15 credit hours toward the J.D. degree for courses qualifying under this standard.

ES = satisfies the upper level skills course requirement (Class of 2018)

AND

satisfies the upper level experiential learning requirement** (Class of 2019 and 2020)

R = satisfies the upper level writing requirement

E = satisfies the upper level experiential learning requirement** (Class of 2019 and 2020)

The experiential learning requirement replaces the Skills requirement. Classes of 2017 and 2018 are not affected by the new experiential learning requirement, but must still satisfy the Skills requirement.

****Beginning with the Class of 2019, students must graduate with six (6) hours of experiential learning courses.**
